**Update on Arbitration Award**

The Commercial Court, Dehradun, Uttarakhand has passed order dated 08.08.2025 directing Public Works Department, Government of Uttarakhand to deposit the entire amount of Arbitration Award dated 31.01.2022 (read with correction & interpretation dated 14.02.2022) regarding the Road Project of "Improvement/Strengthening of 15 roads in District - Almora (Package C-4), Phase-III"

The Arbitration Award Sum as on 06.08.2025 is Rs 77.85 crores and further interest is accruing at the rate of 2% higher than the current rate of interest prevalent on the date of award in terms of Section 31(7) of the Arbitration and Conciliation Act 1996 (which is currently 8.90% p.a.) till the date of payment.
